




PUBLIC FUNDING

Public funding for schools is provided by the Australian Government and state and territory governments.

State and territory governments are the main public funding source for government schools. The Australian Government is the main public funding source for non-government schools, providing 76% of total government recurrent funding for Independent schools while states and territories provide 24%.



The proportions of private/ government funding vary greatly from school to school.

THE SCHOOLING RESOURCE STANDARD (SRS) FUNDING MODEL

The current needs based funding model for schools comprises base funding plus loadings to address educational disadvantage. Base funding is adjusted according to the school community's estimated capacity to contribute (CTC) to the costs of education assessed on parental income tax data.

This methodology is known as the Direct Measure of Income (DMI). Schools with a higher parental income receive less per capita base funding All loadings are fully publicly funded.


In 2020, it is estimated that grants for capital works for the Independent sector will total approximately \$67 million. Grants are distributed on a needs basis through Block Grant Authorities, with priority given to disadvantaged school communities with the least capacity to raise funds.

STATE AND TERRITORY **CAPITAL FUNDING**

State and territory government assistance for capital funding is limited. Several state and territory governments also provide interest subsidy arrangements.
